In British English the present perfect is used to express an action that has occurred in the recent past that has an effect on the present moment. For example:²²

I've lost my key. Can you help me look for it? In American English the following is also possible: I lost my key. Can you help me look for it?

In British English, the above would be considered incorrect. However, both forms are generally accepted in standard American English. Other differences involving the use of the present perfect in British English and simple past in American English include **already**, just and yet.

British English

I've just had lunch.
I've already seen that film.
Have you finished your homework yet?

American English

I just had lunch OR I've just had lunch.
I've already seen that film OR I already saw that film.
Have you finished your homework yet? OR Did you finish your homework yet?

Possession

There are two forms to express possession in English. Have or Have got Do you have a car?
Have you got a car?
He hasn't got any friends.
He doesn't have any friends.
She has a beautiful new home.
She's got a beautiful new home.

While both forms are correct (and accepted in both British and American English), have got (have you got, he hasn't got, etc.) is generally the preferred form in British English while most speakers of American English employ the have (do you have, he doesn't have etc.)

The following verbs have two acceptable forms of the past simple/past participle in both American and British English, however, the irregular form is generally more common in British English (the first form of the two) and the regular form is more common to American English.

According to the 1990 census, 97 percent of U.S. residents speak English "well" or "very well". Only 0.8% (8 people out of a thousand) speak no English at all, as compared with 3.6 percent in 1890. As of 2004, more than two-thirds of native speakers of English use the American dialect.

American English has further changed due to the influx of non-English speakers, whose words sometimes enter American vernacular. Many words have entered American English from Spanish, Native American languages, and so on.

American English has both spelling and grammatical differences from British English, some of which were made as part of an attempt to rationalize the English spelling used by British English at the time. Unlike many 20th

century language reforms (e.g., Turkey's alphabet shift, Norway's spelling reform) the American spelling changes were not driven by government, but by textbook writers and dictionary makers.

The first American dictionary was written by Noah Webster in 1828. At the time America was a relatively new country and Webster's particular contribution was to show that the region spoke a different dialect from Britain, and so he wrote a dictionary with many spellings differing from the standard. Many of these changes were initiated unilaterally by Webster.

Webster also argued for many "simplifications" to the idiomatic spelling of the period. Somewhat ironically, many, although not all, of his simplifications fell into common usage alongside the original versions, resulting in a situation even more confused than before.

Many words are shortened and differ from other versions of English. Spellings such as *center* are used instead of *centre* in other versions of English. Conversely, American English sometimes favors words that are morphologically more complex, whereas British English uses clipped forms, such as AmE *transportation* and BrE *transport* or where the British form is a back-formation, such as AmE *burglarize* and BrE *burgle* (from *burglar*).

Learning American English pronunciation is easy. Contrary to some beliefs, you don't need to memorize the signs and symbols of the American English phonetic alphabet to do so. After all, native speakers of American English learn how to pronounce words most often by listening and repeating and many of them have never even seen the phonetic alphabet. You don't need to enroll in a class or course to improve your American English pronunciation. Instead you can just take advantage of the many sources that abound on the Internet.
